## Undergraduate Scholarship Eligibility & Requirements

MI Future Scholarships are available to students who are 1) studying for a career in the independent agency system (curriculum must have emphasis on insurance or a related business field such as finance, marketing, etc.), 2) planning to pursue a career in the independent agency system after graduation, and 3) entering their sophomore, junior or senior year with at least one full year of undergraduate school remaining beginning with the 2011-2012 school year.

In addition, each applicant must submit the following:

- ◆ A completed/signed 2011-2012 MI Future Scholarship Application (This form grants MI Future the right to publicize and print any or all of the student's entry and/or photograph).
- ◆ Two (2) letters of recommendation from two (2) of the following sources: academic advisor, counselor, teacher/professor, employer or insurance professional. Applications will not be processed until recommendation letters are received.
- ◆ A one to two-page essay summarizing your career goals, academic accomplishments, work experience, pertinent extracurricular activities, why you are applying for this scholarship, and why insurance is your career of choice.
- ◆ A copy of current school transcript which includes grade point average to date. Also, please attach a copy of your résumé if available.
